## **CONSECUTIVE DIALOGUE - EXERCISE 1**

Q. Ms. King, you're Jack King's wife?

A. Yes.

- Q. Okay. Did you see this fight happen?
- A. I just saw part of the fight. Not the whole thing.
- Q. Tell me what you saw.
- A. I heard yelling in the hallway.
- Q. Did you see anything going on in the hallway?
- A. No. I was in the room.

Q. Before the yelling was going on in the hallway, was there an altercation between your husband and your daughter Adele in the bedroom?

A. They were drinking when I saw them.

Q. Okay. And when you were in the bedroom, was there an argument that took place between your daughter Adele and your husband Jack?

A. They were just drinking.

Q. I understand that but was there an argument that took place between the two of them?

A. They weren't arguing; they were just talking regular-like.

Q. Okay. At any point, did you see your husband get up and grab your daughter in a physical manner?

A. I don't know.

Q. Okay, because you don't remember or ...?

A. No, I don't remember.

Q. So this altercation that started in the hallway, how did that start?

A. I don't know. I was in the washroom and when I came back to the room they got up quickly and left the room.

Q. Okay, who got up quickly?

A. William and Jack.

Q. Okay and then what happened?

A. I just sat back down where I was sitting before. Adele said she had to go to the washroom.

Q. Okay and what happened after that?

A. While I sat there, I heard yelling in the hallway.

Q. Okay. Who was yelling in the hallway?

A. I heard Adele yelling and him.

Q. Adele and William yelling?

A. Yes. Adele was yelling "Don't".

Q. Did you hear anything else coming from the hallway?

A. That's all I heard.

Q. Okay. So while this yelling was going on in the hallway, you were in the bedroom?

A. Yes.

Q. You just sat there while all this was going on....?

A. There was already blood in the hallway, and I didn't want to get up.

Q. Why was it then that you told the police that your husband Jack was in the hallway with Mr. Fisher when you left the house the first time?

A. Can you repeat the question?

Q. Why did you tell the police that your husband Jack was in the hallway with William Fisher when you left the house the first time?

A. That's not what I meant.

Q. Okay. So while Jack and William were in the hallway, you didn't leave the house then?

A. No. Jack, William and Adele had already left from the residence before me. They weren't there when the police arrived. I was told by the officer not to step on the blood as I left. And then I left and went home, and when I got home, my son Charlie told me that Jack was in the hospital. And then I went looking for Adele and after that we went to the hospital.

Q. What condition was your husband in, in the house? In Lionel Benson's house?

A. He was drinking.

Q. Okay. Was he injured?

A. No.

Q. Do you know how the blood got on the floor?

A. It was from his eye that got injured.

Q. Okay, but you just indicated to me that he wasn't injured.

A. When I said that, I meant before he got – before he was hit.

Q. Okay, but you didn't see any of that altercation, right?

A. No, I didn't see that. I thought they were just simply – just I guess talking.

Q. Okay. So, how was it then that all this happened while you're in the bedroom and you just stay in the bedroom the whole time?

- A. I just sat there when they told me not to walk on the blood.
- Q. Who told you that?
- A. Hunter.
- Q. Okay, that's the police?
- A. Mm-hmm.

Q. But the police arrived later, right? So while you're in the bedroom and Jack's in the hallway, you just continue to stay in the bedroom and you don't see Jack at any point?

- A. I guess not.
- Q. And when the police arrived, what did they do?
- A. They saw the blood and called the ambulance.
- Q. To go to Lionel' house?
- A. It didn't come there. It went to our house because Jack had left Lionel's house.

Q. So after everything stopped in the hallway, you stayed in the bedroom then, is that correct?

- A. Mm-hmm.
- Q. Where did your husband Jack go?
- A. He went home.
- Q. Where did Adele and William go?
- A. I don't know where they went. I was just yelling for Adele.
- Q. Where did Lionel go? Lionel Benson?
- A. He was sitting in the room.
- Q. How long after all of this did your husband leave to go home?
- A. He went home right after this happened.
- Q. And how long after this did Adele and William leave?
- A. I think they went about the same time.
- Q. Did they leave separately or leave together?
- A. That's what I don't know, that's why I was yelling.

Q. And from that point on until the police arrived, you just stayed in the bedroom?

- A. Yes. I was told not to step on the blood.
- Q. All right. Thank you. I have no further questions.
